

RESOLUTION NO. 5953

A RESOLUTION APPROVING SCOPE OF SERVICES BY MIKE THEDFORD, d/b/a THEDFORD ENTERPRISES FOR THE SOUTH ELGIN STREETScape PROJECT – BLUE DOME TIF

WHEREAS, the Tulsa Development Authority (TDA or Authority) and Mike Thedford d/b/a Thedford Enterprises (Thedford) have previously entered into a Consulting Services Agreement (Agreement) whereby Thedford agreed to perform project management, construction management and supervision, including without limitation quality control and verification of compliance with plans and specifications for projects funded by Tax Increment Districts (TIFs) managed TDA (“Services”) and preparation and presentation of reports to the Board of Commissioners of the Authority and the City of Tulsa Economic Development Coordinator; and,

WHEREAS, the said Agreement further provides that the specific Scope of Work to be performed by Thedford as to any particular TIF project shall be set forth in a separate written Scope of Services Agreement to be prepared by Authority and submitted to Consultant for acceptance and written approval on a project by project basis; and,

WHEREAS, the said Agreement further provides that each such Scope of Services Agreement shall specify the Scope of Services and a cost estimate for services to be performed by Consultant and shall be subject to the separate approval by a majority of the Board of Commissioners of the Authority; and,

WHEREAS, Thedford has requested and TDA’s Executive Director has recommended that the TDA approve the provision of Services for the South Elgin Streetscape Improvements Project not to exceed a total of 130 hours over the next four (4) months for project management services; and,

WHEREAS, the Board of Commissioners of the Tulsa Development Authority, based upon the recommendations of its Executive Director, believes that it would be in the best interest of the TDA, the City of Tulsa and the general public to approve said Services by Thedford upon the proposed terms and conditions as set forth above and the terms and conditions of the Consulting Services Agreement between TDA and Thedford.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TULSA DEVELOPMENT AUTHORITY, to-wit:

Section 1. That the Board of Commissioners of the Tulsa Development Authority does hereby approve the provision of Services by Thedford for the South Elgin Streetscape Improvements Project, not to exceed a total of 130 hours over the next four (4) months for project management services, in accordance with the terms and conditions of the Consulting Services Agreement between TDA and Thedford.

Section 2. This Resolution shall take effect immediately.
