

RESOLUTION NO. 6091

**RESOLUTION APPROVING REFUND OF GOOD FAITH/EARNEST  
MONEY DEPOSIT TO MISSILE ENTERPRISES FROM TDA FUND NO. 5540  
IN THE AMOUNT OF \$1,160.00**

**WHEREAS**, certain staff members of the City of Tulsa (City) and the Tulsa Development Authority have reviewed a certain good faith/earnest money deposit in the amount of \$1,160.00 held in Tulsa Development Authority (TDA) Fund No. 5540 from previous redevelopment contract between the Tulsa Development Authority (TDA) and Missile Enterprises; and,

**WHEREAS**, said City staff members and staff of the TDA have agreed that a refund should be made to Missile Enterprises in the total amount of \$1,160.00 from a certain good faith/earnest money deposit held in Tulsa Development Authority (TDA) Fund No. 5540 from a previous redevelopment contract between the Tulsa Development Authority (TDA) and Missile Enterprises for parcel 11-10-I10; and,

**WHEREAS**, the Board of Commissioners of the TDA has determined that the TDA should refund to Missile Enterprises the total amount of \$1,160.00 held as good faith/earnest money deposit, which sum is currently held in said TDA Fund No. 5540 and therefore does further approve the payment and transfer from TDA Fund No. 5540 to Missile Enterprises of the amount of \$1,160.00 as and for a refund of good faith/earnest money deposit.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TULSA DEVELOPMENT AUTHORITY, to-wit:**

**Section 1.** That the Board of Commissioners of the Tulsa Development Authority does hereby authorize and approve the refund of a good faith deposit by Missile Enterprises in the total amount of \$1,160.00 held in Tulsa Development Authority (TDA) Fund No. 5540 from a previous redevelopment contract between the Tulsa Development Authority (TDA) and Missile Enterprises.

**Section 2.** That the Board of Commissioners of the Tulsa Development Authority does hereby authorize and approve the payment and transfer from TDA Fund No. 5540 to Missile Enterprises in the amount of \$1,160.00 as and for a refund of a good faith deposit from a previous redevelopment contract between the Tulsa Development Authority (TDA) and Missile Enterprises.

**Section 3.** This Resolution shall take effect immediately.


