

RESOLUTION NO. 6479

**RESOLUTION APPROVING THE  
CRUTCHFIELD AREA NEIGHBORHOOD SECTOR PLAN**

**WHEREAS**, the Tulsa Development Authority (“TDA”), as the Urban Renewal Authority for and created by the City of Tulsa, and pursuant to Title 11 Oklahoma Statutes, Section 38-106, has prepared an Urban Renewal Plan for The Crutchfield Area Neighborhood, known as the Crutchfield Area Neighborhood Sector Plan, attached hereto as Attachment 1 (“the Plan”); and,

**WHEREAS**, it is necessary for the adoption, approval and implementation of the Plan that it be submitted to the TMAPC, for public hearing, due study and deliberation, and adoption of the Plan as an amendment to the Tulsa Comprehensive Plan; and,

**WHEREAS**, it is further necessary for adoption, approval and implementation of the Plan that, following publication and posting of notices as required by law, and pursuant to the requirements of 11 O. S. §38-106, two public hearings be held by the City Council of the City of Tulsa, Oklahoma (the “Tulsa City Council”), following which the said Tulsa City Council must approve and adopt the Plan and approve the amendment of the Tulsa Comprehensive; and,

**WHEREAS**, The Board of Commissioners of the Tulsa Development Authority, upon the recommendation of the TDA’s Executive Director, has determined the Tulsa Development Authority should approve the Plan and direct the staff of the TDA to proceed with submission of the Plan to the TMAPC and the Tulsa City Council for, following notice as required by law, approval and adoption, following which the approved and adopted Plan shall be returned to the TDA’s Board of Commissioners for adoption of the approved Plan and authorization of TDA staff to proceed with development and implementation the Plan.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TULSA DEVELOPMENT AUTHORITY, that:**

**Section 1.** The Board of Commissioners of the Tulsa Development Authority, upon the recommendation of the TDA’s Executive Director, has determined the Tulsa Development Authority should approve The Crutchfield Area Neighborhood Sector Plan (the “Plan”).

**Section 2.** The Board of Commissioners of the Tulsa Development Authority does hereby direct the staff of the TDA to proceed with submission of the Plan to the TMAPC and the Tulsa City Council for, following notice as required by law, approval and adoption, following which the approved and adopted Plan shall be returned to the TDA’s Board of Commissioners for adoption of the approved Plan and authorization of the TDA staff to proceed with development and implementation of the Plan.

**Section 3.** This Resolution shall take effect immediately.
