| Other | <i>Novus Homes (Wilkins)</i> | <i>CV-2016-998</i> | Filed by Wilkins seeking declaratory judgment that TDA violated open meeting act with regard to issuance of Block 44 - Judge Pickerill has ruled that a previous order entered in the case dealt only with the denial of summary judgment sought by TDA and did not constitute a finding that TDA had violated the Open Meeting Act. - Plaintiffs' Motion for attorney fees denied. - Case remains pending with scheduling conference to be set upon application. |
| Other | <i>Vanessa Hall-Harper et. al v. TDA</i> | <i>CV-2017-1049</i> | Filed by Tulsa City Councilor Vanessa Hall-Harper (in her individual capacity) and others alleging violation of the Open Meeting Act. - A protective order has been entered re personal information. Scheduling Order entered May 4, 2018. Preliminary Witness and Exhibit Lists have been exchanged by June 31, 2018. - - Discovery is ongoing – TDA has filed its response to Plaintiffs' Second Discovery Requests. Plaintiffs have submitted an offer of settlement. Case remains pending. |
| Declaratory Judgment | <i>UCAT v TDA</i> | <i>CV-2018-127</i> | Action for declaratory judgment filed by UCAT on February 2, 2018. Mediation conducted on May 10 th , 2018. TDA and UCT representatives reached a settlement of the pending litigation which has been finalized. - Written settlement agreement has approved by the boards of the parties and signed by Chairman of both. An Order is to be filed. TDA is in the process of obtaining a survey and preparing legal description of the land to be recovered to TDA. |
