

RESOLUTION NO. 6570

**RESOLUTION APPROVING NON-BINDING NEGOTIATIONS WITH  
CROSSOVER COMMUNITY IMPACT, INC. FOR TERM SHEET AND  
PROPOSED TERMS OF A FINANCING ASSISTANCE AGREEMENT  
BETWEEN TDA AND CROSSOVER COMMUNITY IMPACT, INC.  
– NORTH TULSA TIF**

**WHEREAS**, the Tulsa Development Authority (TDA) is in the process of preparing and seeking approval of a Tax Increment Financing district (TIF) to be known as the North Tulsa TIF; and,

**WHEREAS**, CROSSOVER COMMUNITY IMPACT, INC. (“CCI”) has requested (North Tulsa TIF Application No. 2) that TDA enter into non-binding negotiations for a “Term Sheet” setting forth the proposed terms and conditions of a Finance Assistance Agreement between TDA and CCI for funding from the North Tulsa TIF to assist in CCI’s economic development activities upon CCI’s Property located in Sections 23 and 24, Township 20 North, Range 12 East of the Indian Meridian, Tulsa County, Oklahoma; and,

**WHEREAS**, the TDA Board of Commissioners has determined that it should approve and authorize such negotiations.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TULSA DEVELOPMENT AUTHORITY, to-wit:**

**Section 1.** The Board of Commissioners of Tulsa Development Authority does hereby authorize its Chairman, Executive Director, General Counsel and Special TIF Counsel to enter into non-binding negotiations with representatives of CROSSOVER COMMUNITY IMPACT, INC. for a “Term Sheet” setting forth the proposed terms and conditions of a Finance Assistance Agreement, and the negotiation of a Finance Assistance Redevelopment Agreement, between TDA and CCI for funding from the North Tulsa TIF to assist in CCI’s economic development activities upon CCI’s Property located south of East 36<sup>th</sup> Street North and west of North Peoria Avenue, Tulsa, Oklahoma.

**Section 2.** That this authorization to negotiate a Term Sheet and a Finance Assistance Agreement, as herein described, is contingent and conditioned upon the prior receipt by the Tulsa Development Authority of the written acknowledgement and agreement by the appropriate officer/manager of CROSSOVER COMMUNITY IMPACT, INC., on behalf of itself, and its owners, officers, managers, members and successors:


- (1) That no Term Sheet, nor Financing Assistance Agreement related thereto, from TDA, shall be in effect unless and until it shall have been approved and executed by the Chairman of the Board of Commissioners of the TDA; and,

(2) That either party (i.e. TDA or CCI) shall have the right to terminate the negotiations at any time without cause and without any further liability to the other, including within such exclusion of liability, without limitation, any costs, fees or other expenses incurred by either party in the course of preparation for and/or participation in such negotiations.

**Section 3.** This Resolution shall take effect immediately.
