

RESOLUTION NO. 6596

**RESOLUTION APPROVING TRANSFER OF TDA FUNDS TO TDA FUND NO. 712 AND RE-AUTHORIZATION FOR EXPENDITURE OF FUNDS TO PROVIDE TORNADO RELIEF ASSISTANCE TO UNDER-SERVED FAMILIES AFFECTED BY THE MARCH 30, 2016 STORM**

**WHEREAS**, on March 30, 2016, portions of the City of Tulsa experienced severe weather and residential structures located in an area of North Tulsa were damaged, the boundary of said area being: North – East 52<sup>nd</sup> Street North; South – East 40<sup>th</sup> Street North; East – Highway 75; and West – North Osage Drive; and,

**WHEREAS**, the mission of the Tulsa Development Authority (TDA) includes providing programs and funding that help the residents of the affected neighborhood to thrive and sustain their viability; and,

**WHEREAS**, on May 5, 2016 (Resolution No. 6210), the TDA Board of Commissioners authorized the TDA collaborate with the City of Tulsa Working in Neighborhoods (WIN) Department in a program that would enhance the longevity and sustainability of the affected area by providing the funding in the form of grants of up to \$5,000.00 per residence for repairs needed to re-establish safe and sanitary housing to under-served residents affected by the tornado and approved and expenditure of TDA funds up to the amount of \$200,000.00 from TDA Fund No. 3104 (now No. 712) for such purpose; and,

**WHEREAS**, it has been determined that the Board of Commissioners of TDA should re-appropriate \$35,000.00 into TDA Fund No. 712 and re-authorize the TDA expenditure of funds from TDA Fund No. 712 in an amount not to exceed \$35,000.00 for use in providing such tornado relief assistance to the affected area above described, all in accordance with details contained in the staff report submitted to the TDA Board of Commissioners this date.


**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TULSA DEVELOPMENT AUTHORITY, that:**

**Section 1.** The Board of Commissioners of the Tulsa Development Authority (TDA) hereby re-appropriates \$35,000.00 into TDA Fund No. 712 and re-authorizes the TDA expenditure of funds from TDA Fund No. 712 in an amount not to exceed \$35,000.00 for use in providing such tornado relief assistance to the affected area above described, all in accordance with details contained in the Staff Report submitted to the TDA Board of Commissioners this date.


**Section 2.** This Resolution shall take effect immediately.
